**Beginning of project: begins when \$208.40 staking fee is paid that is non-refundable.** Please provide legal land description and amp size of service. We will make arrangements for our Staking Technician to meet you on site, then it will be staked and GPS'd for the right-of-way. All line builds are required to have an archaeological record search (which Lacreek will do). A concurrence letter from OST Cultural Affairs & Historic Preservation Office will be needed from their office to continue with the line build, at the consumer's expense. **Projects take time, therefore, do not wait until the last minute to start the paperwork.**

**Meter loop fee is \$200.00 plus tax.** If we have to re-stake the service another \$208.40 will be charged and applied to the cost. Confirmation of water supply is needed before the line is constructed, if residential. **Wiring Certificate:** Every service is required to have an Electrical Wiring Certificate if it is located in the state of South Dakota. Before a line can be built or a new service connected, a wiring permit must be submitted to the electrical supplier. You can purchase wiring permit from an electrician of your choice or SD Electrical Commission, 1-800-233-7765 or 1-605-773-5087 or any electrician of your choice.

**RIGHT OF WAY –**

***Tribal or Trust Land*** – the right of way will be granted when easements or consent forms are signed by the landowners and approved by the Bureau of Indian Affairs.

***Deeded Land*** – the right of way will be granted when the deeded easement is signed and notarized by the landowner and filed with the Register of Deeds in the appropriate county. **WE CANNOT COMPLETE THE LINEBUILD UNTIL THE RIGHT OF WAY IS GRANTED, THEREFORE, THE TIME FRAME ON PROJECTS VARY AND MAY TAKE SEVERAL WEEKS OR MONTHS.**

**PERFECTION OF RIGHT OF WAY: (Non-refundable) \$204.08:** This must be paid before line will be constructed. An invoice will be sent out with the instruction packet.

Security light install is \$75.00 plus \$3.15 tax prepaid before installation.

**Five Year Contract:** All single phase services are required to have a 5-year contract with a beginning date of contract being date of service being energized. If the site is abandoned or disconnected, the monthly minimum must be paid to the ending date of contract. 10-yr contracts are required for 3 phase services.

**Aid to Construction:**

**Single phase** – determined by footage. The current rate is \$7.00 per foot after the allowed lump sum is subtracted from the total. Allowed lump sum of \$3,150.00 before Aid To Construction costs apply for wells, trailers and permanent foundations.

**Three phase:** seasonal or irrigation services will be allowed \$ amount of \$6,500, remainder is \$15.00 per foot whether overhead or underground. **Three phase:** Commercial Business Services allowed \$ amount of \$13,000, remainder is \$15.00 per foot whether overhead or underground. Trenching is \$2.50 per foot for the entire length of the easement.

**\$200.00 deposit will be required on all new accounts.**
